FEATURES AND PROCEDURES
VEGAS NIGHTS
(Instant Scratch Game #2070)

- 1) Theme and name of the game: VEGAS NIGHTS. VEGAS NIGHTS has four separate casino-themed games plus a BONUS area on each \$5 ticket. A different playstyle is employed in all four games and the BONUS area.

BLACKJACK: Add cards in each PLAYER's Hand. Beat the DEALER'S HAND, win prize for that same Hand. If DEALER BUSTS ("B"), win prizes for all five PLAYER hands. K, Q, J = 10; A = 11.

HIGH STAKES ROULETTE: If you match YOUR NUMBER to any Number in the High Stakes wheel, win Prize shown for that matching Number.

HIGH ROLLER: If your total score is 7 or 11 in any one ROLL, win PRIZE shown for that same ROLL.

SLOTS OF MONEY: Match 3 across in any one SPIN, win prize shown in legend.

BONUS: Scratch BONUS area. Find two matching cards, win \$50 instantly.

- 2) Price of the ticket: Five dollars (\$5.00), or as otherwise set by the Administrator.
- 3) The prize structure including the number and value of prizes and the odds on each prize are as follows:

Odds and prize statements are based on initial game prize structure and may vary over the life of the game. Entry or non-entry of VEGAS NIGHTS tickets to the Lottery Super 2nd Chance drawings does not affect the prize structure of the VEGAS NIGHTS game.

- 4) The frequency of drawings: There are no drawings in the VEGAS NIGHTS game, however, for a period of time, at the discretion of the Lottery Division Administrator, VEGAS NIGHTS tickets may count towards entry in Lottery Super 2nd Chance drawings. The Wisconsin Lottery will not be responsible for any neglect, failure or omission on the part of the U.S. Postal Service or any other delivery/courier service used to deliver a player's Super 2nd Chance Drawing mailing to the Wisconsin Lottery. The Lottery assumes no responsibility or liability for Super 2nd Chance tickets that are lost, or destroyed or otherwise disqualified from participation in a drawing when such tickets are in the control of the Lottery. All tickets sent to the Wisconsin Lottery to enter the Super 2nd Chance drawings become property of the Wisconsin Lottery and will not be returned. Only tickets sent to and received at the correct address for entry into the Super 2nd Chance drawing will be eligible for the Super 2nd Chance drawing.
- 5) The method of selecting winners: There are four (4) separate casino-themed games and one (1) BONUS area on each five dollar (\$5.00) ticket. Each game is played separately.

BLACKJACK: The holder of a ticket with a total card count in any one (1) uncovered PLAYER 1-5 play area that is greater than the total in the uncovered DEALER'S HAND play area shall win the prize amount corresponding to (i.e. – shown directly below) that same PLAYER. Each PLAYER Hand is played separately. The holder of a ticket showing a BUST "B" play symbol in the uncovered DEALER'S HAND play area shall win an amount equal to the total sum of the prize amounts corresponding to all five (5) PLAYER 1-5 prize areas automatically, regardless of the total card count for each PLAYER 1-5. Cards are worth their face value with A (Ace)=11; and K (King), Q (Queen), J (Jack)=10.

HIGH STAKES ROULETTE: Each uncovered HIGH STAKES ROULETTE play area contains a boxed YOUR NUMBER play spot, and six (6) play spots around the YOUR NUMBER play spot, each with a corresponding prize amount printed directly below it. The holder of a ticket showing a number in any of the six (6) uncovered play spots in the HIGH STAKES ROULETTE wheel play area that matches the one (1) number in the uncovered YOUR NUMBER play spot shall win the corresponding prize amount shown for that same matching HIGH STAKES ROULETTE wheel play spot.

HIGH ROLLER: The holder of a ticket where the total sum of the two (2) play spots of any one (1) uncovered ROLL is equal to 7 or 11 shall win the corresponding prize amount shown under the PRIZE spot for that same ROLL. Each ROLL is played separately.

SLOTS OF MONEY: The holder of a ticket showing three (3) like play symbols in the uncovered play area of any one (1) SPIN shall win a prize amount equal to the corresponding prize shown for that same winning symbol in the Legend to the right of the play area. Each SPIN is played separately.

BONUS: The holder of a ticket showing two (2) like card symbols in the uncovered BONUS play area shall win fifty dollars (\$50).

- 6) The method of making payment to winners:
- A. Submission of the original ticket (not a copy), as provided below, shall be the sole method of claiming a prize.
 - B. Payment of prizes under six hundred dollars (\$600) may be made by presenting the ticket for validation and payment to any Wisconsin Lottery retailer.
 - C. The original winning ticket must be signed by a single human being. For-profit and non-profit entities, trusts, and other non-human beings are not eligible to play or claim a prize in this game. Payment of any prize totaling five hundred thousand, nine hundred and ninety-nine dollars (\$500,999) or less may be made by either 1) signing the back of the original winning ticket, completing a Lottery claim form and presenting it in person to any Lottery office for validation and payment by the claim deadline under section 6(G) of these features and procedures, or 2) by signing the back of the original winning ticket, completing a Lottery claim form and mailing it for validation and payment to Lottery Headquarters in Madison. If claiming a prize by mail, the original winning ticket and Lottery claim form must be mailed to Lottery Headquarters in Madison by the claim deadline under section 6(G), in a properly addressed envelope with the postage duly prepaid. Payment of any prize totaling five hundred and one thousand dollars (\$501,000) or more must be made by signing the back of the original winning ticket, completing a Lottery claim form and presenting it in person to the Lottery Headquarters in Madison for validation and payment by the claim deadline under section 6(G). Personal appearance may be waived at the Lottery Division Administrator's sole discretion.
 - D. Tickets are void if stolen, unissued, mutilated, altered, counterfeit, or otherwise fail validation tests. The Lottery at its sole discretion reserves the right to pay any mutilated ticket based upon the facts and circumstances of the particular claim. Such action by the Lottery is final and non-reviewable.
 - E. Tickets are void if misprinted. "Misprinted" means any mistake or difference from the original ticket or game specifications of any kind in the printing, manufacturing, packaging or other processing related to the production or distribution of the ticket caused by the raw materials, processes or handling of the ticket until its ultimate sale to the consumer/player. "Misprinted" includes but is not limited to the tickets being unreadable, misregistered, defective, or multiply printed. Also, "misprinted" includes errors in the computer software, computer hardware, code or programming of the game regardless of whether the errors were imbedded or caused by human action relating to any of the matters mentioned in this paragraph. The Lottery at its sole discretion reserves the right to pay any such "misprinted" ticket based upon the facts and circumstances of the particular claim. Such action by the Lottery is final and non-reviewable.
 - F. All tickets sent to the Wisconsin Lottery for the purpose of redemption become property of the Lottery and will not be returned.

- G. The holder of a winning VEGAS NIGHTS ticket must claim the prize, in accordance with section 6(C), within one hundred eighty (180) calendar days after game's end date or the prize shall be forfeited. If claiming a prize by mail, the postage prepaid envelope containing the original winning ticket and Lottery claim form must be postmarked on or before the one hundred eighty (180) day deadline. The envelope containing the original winning ticket and Lottery claim form must be received by the Wisconsin Lottery Headquarters within fourteen (14) calendar days after the one hundred eighty (180) day deadline or the prize shall be forfeited.

- H. Pursuant to Wisconsin's Open Records law (sec. 19.31-19.39 Wis. Stats.), the Lottery is required to disclose a winner's name, place of residence and, if acquired, likeness. If a player wins and claims a prize, the Lottery may use his or her name, likeness and place of residence without compensation for any purpose. Upon claiming a prize, a winner waives any claims against the Lottery and its representatives for any and all liability which may result from the disclosure or use of such information.

- I. Prize payments are subject to the provisions of sec. 565.30 Wis. Stats.
