

**FEATURES AND PROCEDURES****WISCONSIN'S POWERBALL NEW YEARS ROCKIN' EVE LIMITED TIME OFFER**

For a limited time, WISCONSIN'S POWERBALL tickets may be eligible for entry into the NEW YEAR'S ROCKIN' EVE VIP EXPERIENCE DRAWING (NYRE DRAWING). Only those sections of the WISCONSIN'S POWERBALL Features and Procedures that have changed for this Limited Time Offer are represented in this document. Unless amended by this document, all provisions of the WISCONSIN'S POWERBALL Features and Procedures remain in effect for this Limited Time Offer. This limited time offer starts May 1, 2019 and will be available until 8:59:59 PM May 25, 2019.

**A. The theme and name of the game:**

The following paragraph is added after paragraph 4:

WISCONSIN'S POWERBALL tickets purchased between 12:00:00 AM May 1, 2019 through 8:59:59 PM May 25, 2019 may be eligible for entry into the NYRE DRAWING.

**B. The price of tickets:**

**C. The prize structure, including the number and value of prizes:**

**D. The frequency of drawings:**

The following paragraphs are added after the second paragraph:

For a period of time, at the discretion of the Lottery Division Administrator, WISCONSIN'S POWERBALL tickets may count towards entry in the NYRE DRAWING. The Wisconsin Lottery will not be responsible for any neglect, failure or omission on the part of the U.S. Postal Service or any other delivery or courier service used to deliver a player's NYRE DRAWING mailing to the Wisconsin Lottery. The Lottery assumes no responsibility or liability for NYRE DRAWING tickets that are lost, or destroyed or otherwise disqualified from participation in a drawing when such tickets are in the control of the Lottery. All tickets sent to the Wisconsin Lottery to enter the NYRE DRAWING become property of the Wisconsin Lottery and will not be returned. Only tickets sent to and received prior to the June 4, 2019 drawing at the correct address for entry into the NYRE DRAWING will be eligible for the NYRE DRAWING.

Any POWERBALL ticket entered in the NYRE DRAWING will be ineligible for any prize for which it would otherwise have entitled the holder. Any such ticket entered into the NYRE DRAWING will be considered a non-winning ticket for the purposes of eligibility to qualify for the NYRE DRAWING.

The NYRE DRAWING is a separate drawing from any POWERBALL drawings and the Wisconsin Lottery Super 2<sup>nd</sup> Chance drawings.
