FEATURES AND PROCEDURES

BADGER 5 LIGHTNING BALL LIMITED TIME OFFER

A. The theme and name of the game:

The BADGER 5 LIGHTNING BALL LIMITED TIME OFFER is an addition to the Wisconsin Lottery's BADGER 5 game. Only those sections of the Badger 5 Features and Procedures that are changed for the Badger 5 Lightning Ball Limited Time Offer are represented in this document. Unless amended by this document, all provisions of the Badger 5 Features and Procedures remain in effect for the Badger 5 Lightning Ball Limited Time Offer. This limited time offer will be available only from February 1, 2021 to February 28, 2021, inclusive.

Section A of BADGER 5 features and procedures shall be changed as follows:

The name of this game is BADGER 5. It is a game in which the player selects a set of five (5) different numbers from one (1) to thirty-one (31). Additionally, one more number (called the "Lightning Ball" and printed after the letters "LB" on each eligible play) will appear on every third (3rd) play of Badger 5 purchased statewide. The Lightning Ball will also be a number from one (1) to thirty-one (31) and will be different from the other five numbers in that same play. At the player's option, the first set of five numbers may be player-selected or randomly selected by computer. All Lightning Ball numbers will be randomly selected by the computer at the time of purchase for each eligible play.

The five (5) winning numbers are randomly selected by a drawing. Numbers within a single play, including the Lightning Ball (if it appears), are matched against the five (5) numbers drawn. There is no separate Lightning Ball drawing.

A pari-mutuel jackpot prize is awarded for correctly matching, in any order, five (5) of the five (5) numbers drawn; the Lightning Ball cannot be used to match a number drawn and win the jackpot prize. Set prizes are awarded for matching, in any order, four (4), three (3), or two (2) of the five (5) numbers drawn where the Lightning Ball (if it appears) does not match any number drawn.

For plays with a Lightning Ball where the Lightning Ball matches one (1) of the numbers drawn, set prizes are awarded for matching, in any order, four (4), three (3), two (2) or one (1) of the five (5) numbers drawn in addition to the Lightning Ball.

For the purposes of the Lottery's Retailer Performance Program, this game is considered a daily game.

B. The price of tickets:

Section 1 shall be changed as follows:

1. The price of a ticket is one dollar (\$1.00), or such other price as set by the Lottery Division Administrator, which entitles the purchaser to enter one (1) play (one (1) set of five (5) different numbers from a field of one (1) to thirty-one (31), with or without a Lightning Ball) in each drawing for which the ticket is purchased.

Section 2 shall be changed as follows:

2. Tickets purchased for the current drawing may also be purchased for the next six (6) drawings. In its sole discretion, the Lottery may designate that fewer than seven (7) drawings are available for purchase. Tickets may only be purchased for consecutive drawings starting with the next drawing available for purchase. Tickets containing a play with a Lightning Ball are eligible for prizes under section C1 as amended below for all drawings (i.e., drawing dates) that ticket is eligible for, including drawings after February 28, 2021.

C. The prize structure, including the number and value of prizes:

Section 1 shall be changed as follows:

1. All prizes are funded solely out of the tickets purchased. Approximately fifty-five and six tenths percent (55.6%) of each dollar played is allocated to prizes. Prizes are awarded as follows for plays without a Lightning Ball:

5 of 5	1:169,911	Guaranteed minimum jackpot of \$10,000, which is divided equally among all valid game plays which match, in any order, five of the five numbers drawn.
4 of 5	1:1,308	Set prize of \$50 for each valid game play which correctly matches, in any order, four of the five numbers drawn.
3 of 5	1:53	Set prize of \$2 for each valid game play which correctly matches, in any order, three of the five numbers drawn.
2 of 5	1:7	Set prize of \$1 for each valid game play which correctly matches, in any order, two of the five numbers drawn.

Prizes are awarded as follows for plays with a Lightning Ball:

MATCH	ODDS	PRIZE
5 of 5	1:169,911	Guaranteed minimum jackpot of \$10,000, which is divided equally among all valid game plays which match, in any order, five of the five numbers drawn. The Lightning Ball cannot be used to match a number drawn and win the jackpot prize.
4 of 5 + LB	1:33,983	Set prize of \$500 for each valid game play which correctly matches, in any order, four of the five numbers drawn and the Lightning Ball matches one of the five numbers drawn.
4 of 5 or 3 of 5 + LB	1:454	 Set prize of \$50 for each valid game play which correctly matches, in any order: four of the five numbers drawn and the Lightning Ball does not match any number drawn, or three of the five numbers drawn and the Lightning Ball matches one of the five numbers drawn.

3 of 5 or 2 of 5 + LB	1:29	 Set prize of \$2 for each valid game play which correctly matches, in any order: three of the five numbers drawn and the Lightning Ball does not match any number drawn, or two of the five numbers drawn and the Lightning Ball matches one of the five numbers drawn.
2 of 5 or 1 of 5 + LB	1:5	 Set prize of \$1 for each valid game play which correctly matches, in any order: two of the five numbers drawn and the Lightning Ball does not match any number drawn, or one of the five numbers drawn and the Lightning Ball matches one of the five numbers drawn.

Section 4 shall be changed as follows:

4. The holder of a winning ticket may win only one (1) prize per play (set of five (5) numbers with or without a Lightning Ball) in connection with the numbers drawn, and shall be entitled only to the highest prize won by matching those numbers.

D. The frequency of drawings:
